PERSONAL & SMALL BUSINESS RECORDS:

1. Previous Year's Federal & State Tax Returns: - Both personal and small business tax returns

2. Current Financial Statements & Bookkeeping Records:

- This includes Profit & Loss statements, balance sheets, etc.

3. Income Records (non-farm):

- You will need all income including 1099's, W2's, etc.

4. Farm Income:

- Including forms 1099-PATR, 1099-MISC (USDA), 1099-NEC, crop insurance proceeds, sales of crops and livestock.
